Notice of Commission Action: **RESCIND** Relinquishment of Accreditation

By letter dated September 1, 2016 NACCAS notified the institution identified below that NACCAS acknowledged and had made effective the institution's request for voluntary relinquishment of its accreditation pursuant to Section 8.13(a) of NACCAS' *Rules of Practice and Procedure*. NACCAS notified the U.S. Department of Education and other interested parties by E-Notice (below) on September 1, 2016.

On September 2, 2016 NACCAS was notified by the institution that its request for voluntary relinquishment of its accreditation was submitted in error. After consultation with the U.S. Department of Education, NACCAS has rescinded its prior relinquishment of the institution's accreditation and is hereby notifying the recipients of the prior E-Notice that such E-Notice is likewise rescinded.

Pursuant to Section 8.13 of NACCAS' *Rules of Practice and Procedure*, an accredited institution (1) shall be deemed to have relinquished its accreditation if it fails to respond to a "show cause" order relating to certain institutional changes, or if the response to such a "show cause" order does not warrant another action and (2) may voluntarily relinquish its accreditation at any time by written notice to NACCAS.
