

NACCAS' 2017 Appeal Review Panel

NACCAS' Appeal Review Panel hears appeals of adverse accreditation decisions (as defined in Section 9.0(a) of NACCAS' *Rules of Practice and Procedure*) made by NACCAS' Board of Commissioners. The Panel has the authority to grant or deny appeals, or to send a matter back to the Commission for further consideration.

The Appeal Review Panel consists of seven (7) Panelists (none of whom are current Commissioners) serving overlapping three-year terms. The Panel is composed of:

1. Four (4) School Owners/Administrators;
2. One (1) Academic;
3. One (1) Practitioner; and
4. One (1) Representative of the Public.

Each Panelist is required to meet the same qualifications for his/her position as are required for a Commissioner in the same category, as set forth in NACCAS' By-Laws. (For example, a School Owner/Administrator Panelist must meet the qualifications for a School Owner/Administrator Commissioner.) In addition, every Panelist must have attended a NACCAS Accreditation Workshop within the previous three years.
